*A temporary sign for which an affidavit has been issued, or which is placed or displayed in violation of this ordinance, or has not been properly maintained, or has become detached or has become a hazard to safety, may be impounded by the Township. Upon removal and impoundment of a temporary sign, the Township shall notify the sign owner and/or permit applicant of the Township's intent to dispose of the sign. If it is not claimed and removed from the Township's place of impoundment within five (5) business days from the date of the notice, the Township may dispose of the sign in any manner it deems appropriate.*

The undersigned understands that installing signage expressly prohibited or failing to remove the signage may result in the issuance of a municipal civil infraction citation and/or removal and impoundment of the sign(s), and grants permission for authorized township representatives, including the zoning administrator and his/her designees, to enter the above described property for the purposes of gathering information related to this affidavit, and, when necessary, impounding signs in violation.
