1. Motion by Kish, seconded by Bradley, to approve the Fire Chief's request to hire Adam Ebejer, at the SOG approved Probationary pay rate of \$11.00 per run, effective immediately.

POINTS OF DISCUSSION: \* Chief Smith introduced Mr. Ebejer to the Board and noted his experience in Wildland Fire Fighting, Confined Space Training and High Angle Rescue Training.  
\* Department will send Mr. Ebejer to Fire Fighter I & II Academy in January, 2022, followed by the EMT class.  
\* This hire will bring Fire Department Membership up to 17.

Motion by Bradley, seconded by Kish, to accept the Petition to the Charter Township of Fort Gratiot Board of Trustee's to request DTE Energy Company **REMOVE** the existing light fixture from the utility pole that is located at the center of the tennis court area, under the authority of MCL 247.391 et. seq., as amended, thereby amending the Lake Huron Manor Subdivision Lighting Assessment District to reflect this change; and adopt Resolution (2021-014), Authorizing Preparation of Plans and Cost Estimates to **REMOVE** the exiting light fixture; and Resolution (2021-015), Resolution of Intent to **AMEND** Special Assessment District, setting the 1<sup>st</sup> Public Hearing to review and hear citizen comments, questions and/or objections to the Petition on Wednesday, October 20<sup>th</sup>, 2021, beginning at 7:00 o'clock p.m.
