Shall the limitation on the amount of taxes which may be levied against taxable property in Fort Gratiot Township be increased by 2.5 mills (\$2.50 per \$1,000 of taxable value) for four years, from 2024 through 2027 inclusive, to raise funds to be used exclusively to continue to provide police protection in the Township? This proposal seeks to restore the Township's ability to fully levy a previously approved millage of 2.5 mills, reduced to 2.4577 mills pursuant to the Headlee Amendment to the Michigan Constitution, which expired with the 2023 levy. If levied in full this millage will raise approximately \$1,371,295 in its first year which by law can only be used to provide police protection within the Township.
