

RESOLUTION

TO ADOPT A ONE PERCENT PROPERTY TAX ADMINISTRATION FEE FOR ASSESSING PROPERTY VALUES AND COLLECTING TAX LEVIES

Minutes of a Regular Meeting of the Board of Trustees of Fort Gratiot Charter Township, County of St. Clair, Michigan, held on the 16th day of April, 2025, at 7:00 o'clock p.m., Prevailing Eastern Time.

The following Preamble and Resolution were offered by Member Crawford and supported by Member Buechler:

WHEREAS, The Township of Fort Gratiot, Saint Clair County, Michigan is responsible for assessing ad valorem property taxes, collecting property tax levies, and handling review and appeal matters arising therefrom, and

WHEREAS, PA 503 of 1982 provides for imposition of a property tax administration fee (PTAF) of not more than one (1%) percent and,

WHEREAS, it is the desire of this Township Board to approve and authorize the imposition of a property tax administration fee as a fee to offset the cost incurred in assessing property values, collecting tax levies and in the review and appeal process.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Township Board of Fort Gratiot Township that: The Township Board does hereby approve and authorize the imposition of a property tax administration fee of one percent on all sums voluntarily paid for property taxes before February 15 of the succeeding year in which the same shall become due and payable.

This resolution shall apply to all property tax levies that shall become due in 2025 or any year thereafter and this resolution shall continue in full force and effect unless and until revoked or rescinded by resolution of Fort Gratiot Township Board.

BE IT, FURTHER RESOLVED that the one percent property tax administration fee, within the jurisdiction of Fort Gratiot Charter Township, is adopted.
